ITEMENTRY INTO A MATERIAL DEFINITIVE AGREEMENT.

On October 24, 2011, we entered into a Strategic Alliance Agreement (the “Agreement”)with Petro data Management Services Limited (“PDMS”) and Gateway Global Fabrication Ltd.
