However, pursuant to Cadian Fund LP's Investment Management Agreement, as amended, the Adviser exercises exclusive voting and investment power over securities directly held by Cadian Fund LP. Cadian Capital Management GP, LLC is the general partner of the Adviser. Eric Bannasch is the sole managing member of Cadian Capital Management GP, LLC. Each Reporting Person disclaims beneficial ownership of securities of the Issuer except to the extent any such Reporting Person actually exercises voting or investment power with respect to such securities of the Issuer.
