- (1) Common Stock and Warrants were acquired on 10/20/2017 through conversion of a convertible note on the same terms as the most recent private placement. The Issuer's private placement sold Units at a sale price of \$0.24 per Unit. Each Unit consisted of two (2) shares of Common Stock and one (1) Warrant to purchase one (1) share of Common Stock at \$0.20 per share for a period of 36 months. The average price per share was \$0.12.
- (2) On August 11, 2017, 300,000 warrants expired
