**Item 8.01 Other Events.**

Pursuant to an S-3 (Reg. No. 333-124073) filed April 14, 2005, and effective on May 3, 2005, Affordable Residential Communities Inc. ( ARC ) has outstanding 1,250,000 warrants outstanding and currently exercisable for shares of ARC common stock until expiration on July 23, 2010. A list of the warrant holders and their addresses is maintained by ARC. On July 11, 2006, ARC paid compensation to its non-management directors, which included the issuance of an additional 3,411 shares of common stock of ARC. As a result, effective immediately following the issuance of these shares, the exercise price per share of ARC common stock under the outstanding warrants to purchase ARC common stock will be adjusted to \$18.140 and the total number of shares of ARC common stock issuable upon exercise of all of such warrants will be adjusted to 806,229.
