Item 7.01 Regulation FD

On October 22, 2012, the Registrant issued a press release that announced that the Company completed a comprehensive analysis focused on optimizing the development plans for the Mt. Todd gold project. The company has selected a two-phased strategy to achieve its development goals and economic objectives. The Company intends to complete a preliminary feasibility study in the first quarter 2013 that evaluates the development strategy, and expects to complete a feasibility study for the project in the second quarter of next year. The Company scheduled analyst days in Toronto (October 23) and New York (October 24). A copy of the press release is attached to this report as Exhibit 99.1.
