**Item 1.01 Entry into a Material Definitive Agreement.**

On March 5, 2015, Huntsman International LLC ( **HI** ), a wholly-owned subsidiary of Huntsman Corporation ( **HC** ), entered into a Master Amendment No. 4 to the European Receivables Loan Agreement, the Servicing Agreement, the Liquidation Servicer Agreement and the Transaction Documents, dated as of March 5, 2015 (the **Amendment** ), among, inter alia, HI, Huntsman Receivables Finance LLC, a Delaware limited liability company, Vantico Group S.à r.l., a private limited company formed under the laws of Luxembourg, Barclays Bank plc, as administrative agent, and the other financial institutions party thereto.

The Amendment, among other things, extends the scheduled commitment termination date of the loan facility to March 5, 2018, reduces the facility applicable margin rate and makes certain other amendments to HI s existing European accounts receivable securitization program.

The foregoing does not constitute a complete summary of the terms of the Amendment. The description of the terms of the Amendment is qualified in its entirety by reference to such agreement, attached hereto as Exhibit 10.1 and incorporated herein by reference.
