Except as amended and supplemented hereby, the statement on Schedule 13D, as heretofore amended and supplemented, remains in full force and effect.

Item 5. Interest in Securities of the Issuer.

From August 8,2003 to August 22,2003, Robustos sold 848,595 shares in the Nasdaq National Market.

As of the date of the filing of this Statement, Robustos beneficially owns, and Leslie Koo may be deemed to beneficially own through Robustos, 1,830,771 shares of Ordinary Shares, which represents approximately 3.65% the outstanding Ordinary Shares based upon 50,154,000 shares of Ordinary Shares reported as outstanding as of July 15, 2003, in the Issuer's Form 20-F report for the year ended December 31, 2002.
