### Item 1. Security and Issuer

This statement relates to common stock of Electric City, Corp (the "Company"). The principal executive offices of the Company are located at 1280 Landmeier Road Elk Grove Village, IL 60007.

### Item 2. Identity and Background

- (a) This Schedule 13D is filed on behalf of Richard P. Kiphart.

- (c) Mr. Kiphart is a principal of William Blair & Company, L.L.C., a broker dealer and investment adviser.
- (d) Mr. Kiphart has not, during the last five years, been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors).
- (e) Mr. Kiphart has not, during the last five years, been a party to any civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of which such person was or is subject to a judgment, decree, or final order enjoining future violations of, or prohibiting or mandating activities with respect to, federal or state securities laws or a finding of any violations with respect to such laws.

### Item 3. Source and Amount of Funds or Other Considerations

The funds for the acquisition of the common stock of the Company over consisted of personal funds of Mr. Kiphart. The amount of this transaction was approximately \$2,169,914.00

### Item 4 Purpose of Transaction

The common stock of the Company was purchased by Mr. Kiphart for investment only. Therefore, the plans of Mr. Kiphart with respect to the common stock of the Company do not relate to and would not result in any of the items enumerated in (a)-(j) of Item 4.

### Item 5 Interest in Securities of the Issuer

- (a) As of June 27, 2003, Mr. Kiphart owned 6,575,106 shares of the common stock of the Company, which equals 19.25% of the outstanding shares (34,148,022) of the common stock of the Company. (He has 200,000 shares of Series C Preferred stock which is convertible into 2 million share of ELC at \$1.00 per share, warrants to purchase 50,000 shares of Series C Preferred stock which is convertible into 500,000 shares of common stock at \$1.00 per share, 52,500 shares of Series D Preferred Stock which is convertible into 525,000 of ELC at \$1.00 per share, 550,560 shares of common stock and warrants to purchase an additional 1,006,053 shares at \$1.00 a share)
- (b) Mr. Kiphart owns shares of the common stock of the Company over which Mr. Kiphart has the sole power to vote or to direct the vote and sole power to dispose or to direct the disposition of such shares.
