## Items to be Included in this Report

### Item 7.01. Regulation FD Disclosure

On January 14, 2005, Casey's General Stores, Inc. (NASDAQ: CASY) reported December 2004 same-store sales results. Average gasoline gallons sold per store increased 7.4% in December 2004 compared to December 2003. The average retail price of gasoline sold during December 2004 was \$1.72 per gallon. Same-store sales of grocery and other merchandise increased 8.9% and prepared foods and fountain same-store sales increased 11.5% in December 2004 compared to December 2003.
