Pursuant to the issuer's Board of Directors Compensation Plan, the Board of Directors granted \$100,000 of common stock to each non-employee director under the issuer's 2007 Equity Incentive Plan (As Amended and Restated), based on the \$25.65 closing price of the common stock on June 29, 2011, as quoted on the NASDAQ Global Select Market.
