### TRANSACTION IN OWN SHARES

Bunzl plc ("Bunzl") announces that it has today purchased through Cazenove & Co. Ltd 200,000 of its ordinary shares at a price of 422.965p per share. The purchased shares will be held as treasury shares.

Following the above purchase, Bunzl holds 200,000 ordinary shares as treasury shares. The total number of ordinary shares in issue (excluding shares held as treasury shares) is 449,408,595.

These purchases were made pursuant to the authority that was granted by shareholders at the Annual General Meeting held on 19th May 2004 and are consistent with Bunzl's overall capital management strategy which seeks to maintain an appropriate balance sheet structure. Further purchases may be made from time to time, subject to market conditions and the Company's capital requirements to fulfil its overall strategic priority of growing both organically and by acquisition.
