Unilever NV announces that on 19 March 2008 it purchased 1,000,000 Unilever NV ordinary shares (in the form of depository receipts thereof) at prices between euro 20.180 and euro 20.700 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 16,061 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 149,544,006 Unilever NV ordinary shares in treasury, and has 1,565,183,694 Unilever NV ordinary shares in issue (excluding treasury shares).
