## **Consolidated Financial Results Forecast for Fiscal 2009**

Osaka, Japan, January 28, 2009 Panasonic Corporation (Panasonic [NYSE symbol: PC]) today commented on certain media report in Japan about the company s consolidated financial results forecast for fiscal 2009, ending March 31, 2009.
