Item 8.01 Other Events

The Board of Directors Newtek Business Services, Inc. (the "Company") at its regular quarterly meeting on November¹¹ authorized the buy back on the open market of up to 1,000,000 of its common shares which are traded on the NASDAQ Stock Market. Management was directed to use its discretion in the re-purchase of shares and to report back to the Board as the transaction progresses up to and beyond the expenditure of \$100,000. This one million share authorization replaces the unexercised portions of two previous authorizations and will terminate in one year.
