As previously announced on October 20, 2014, Fifth Third Bancorp ( Fifth Third ) entered into an accelerated share repurchase transaction with Deutsche Bank AG, London Branch, with Deutsche Bank Securities Inc. acting as agent ( DB ) pursuant to which Fifth Third would purchase approximately \$180 million of its outstanding common stock. Fifth Third is repurchasing the shares of its common stock as part of its 100 million share repurchase program, previously announced on March 18, 2014.

On January 6, 2015, Fifth Third was notified by DB that effective Monday, January 5, 2015, they had finished purchasing shares under the October 20<sup>th</sup> agreement. A total of 8,337,875 shares were repurchased upon execution of the agreement, and an additional 794,245 shares were repurchased upon completion of the agreement. The additional shares settled on Thursday, January 8, 2015. In total, 9,132,120 shares were repurchased under the October 20, 2014 agreement, at an average price of \$19.7106.

After the completion of the October 20<sup>th</sup> agreement, Fifth Third had approximately 72 million shares of remaining repurchase authority under its share repurchase program previously announced on March 18, 2014.

DB and certain of its affiliates have performed, and in the future may perform, various financial advisory and other services for Fifth Third and Fifth Third's affiliates for which they have received, and may in the future receive, customary fees and expenses.
