**Item 8.01. Other Events.**

As previously disclosed, on February 12, 2015, Expedia, Inc., a Delaware corporation ( Expedia ), Orbitz Worldwide, Inc., a Delaware corporation, and Xeta, Inc., a Delaware corporation and an indirect wholly owned subsidiary of Expedia, entered into an Agreement and Plan of Merger (the Merger Agreement ).

On August 12, 2015, Expedia elected to extend the termination date of the Merger Agreement from August 12, 2015 until November 12, 2015 pursuant to Section 7.1(d) of the Merger Agreement. No other provisions of the Merger Agreement were amended, and the Merger Agreement remains in full force and effect.

The proposed merger also remains subject to the expiration or termination of the applicable waiting period under the Hart-Scott-Rodino Antitrust Improvements Act of 1976, as amended, as well as other customary conditions.
