The combination will help us address the growing cost of treating chronic diseases in a thoughtful and integrated fashion, since many people need better access to locally based care on an ongoing basis.

As an example, think about patients with diabetes. They can receive care in between visits to their doctor. They'll have face-to-face counseling at store-based health hubs.

And when they need it, they'll be able to get text messages that let them know when their blood glucose levels go out of range.

Patients can also get follow up advice on medication adherence and pick up diabetes-related supplies.
