In December we announced a definitive agreement to acquire Aetna, a leading diversified health care benefits company. It is a purpose-driven decision to combine our two companies to change how health care is delivered and help people achieve their best health at lower cost.

We are beginning to plan for how we will integrate our two companies to deliver on our vision for the future. I am pleased to announce that **Josh Flum**, Executive Vice President, Enterprise Strategy & Corporate Development, will lead the overall integration effort. He has formed an Integration Management Office (IMO) to support the work, led by **Mario Ramos**, Senior Vice President, Corporate Development.

A number of integration planning teams have been created to work with the IMO, and their focus is to meet near-term integration goals, build the pathway to longer-term transformational opportunities, and ensure a flawless Day 1. The work of the integration planning teams will kick off in early February and continue well after the anticipated close in the second half of 2018.

The majority of our colleagues will remain focused on ensuring we continue to drive momentum in our core lines of business to deliver on our 2018 priorities and budget plans. As needed, members of the IMO may reach out to you for assistance with their work.

Please join me in thanking Josh, Mario, and the many colleagues supporting our integration planning efforts, for their work in the months ahead.

The registration statement is not yet effective.
