**Item 3. Source and Amount of Funds or Other Consideration**

The decrease in Mr. Andrea's beneficial ownership was due to the expiration of 1,400,000 options which expired pursuant to their terms since the filing of the Schedule 13D/A on June 12, 2013. In addition, since the reporting person's Schedule 13D/A filing on June 12, 2013, 500,000 options were granted on September 2, 2014 which vest in three annual installments beginning on September 2, 2015 and 500,000 options were granted on August 7, 2015 which vest in three annual installments beginning on August 7, 2016.

**Item 5. Interest in Securities of the Issuer**

(a) Mr. Andrea beneficially owns 8,527,514 common shares, including 8,166,500 shares that may be acquired by Mr. Andrea within 60 days of August 10, 2015, representing 11.7% of the 64,416,035 issued and outstanding shares of the Company's common stock as of August 7, 2015. Pursuant to Rule 13d-3, the 8,166,500 shares that may be acquired by Mr. Andrea within 60 days of August 10, 2015 are also deemed to be outstanding for purposes of computing the percentage of outstanding shares of the Company's common stock owned by Mr. Andrea.
