  - (1) 463 previously owned shares having a market value of \$27.02 per share were delivered in payment of the option price of \$11.19 per share for 1,120 shares acquired pursuant to the exercise of an option granted under the 2002 Plan. In addition, 272 shares were withheld to pay Federal withholding taxes as permitted by the 2002 Plan and option grant.
  - (2) 1,120 shares were acquired pursuant to the exercise of an option granted under the 2002 Plan.
  - (3) 4,379 previously owned shares having a market value of \$27.02 per share were delivered in payment of the option price of \$11.19 per share for 10,575 shares acquired pursuant to the exercise of an option granted under the 2002 Plan. In addition, 2,569 shares were withheld to pay Federal withholding taxes as permitted by the 2002 Plan and option grant.

In addition, 1,666 shares were withheld to pay Federal withholding taxes as permitted by the 2002 Plan and option grant.
