 - (3) The reporting person and each member of the group declares that neither the filing of this statement nor anything herein shall be construed as an admission that such person is, for the purposes of Section 13(d) or 13(g) of the Act or any other purpose, a member of a group with respect to the Issuer or securities of the Issuer. The reporting person disclaims beneficial ownership of the securities owned by Petrus Financial Services, Ltd., except to the extent of the pecuniary interest of such person in such securities.
