These RSUs vest in vest annually in four equal installments beginning 1 year after grant date. (F) 8,000 RSUs granted on May 4, 2011 vested 100% on the first anniversary of the grant date. (G) 8,000 RSUs granted on May 2, 2012 will vest 100% on the first anniversary of the grant date. As of this filing, 42,500 RSU have vested.
