The Reporting Person disclaims beneficial ownership of these securities, and this report shall not be deemed an admission that the Reporting Person is the beneficial owner of the securities for purposes of Section 16 or for any other purpose.

(2) These shares were sold subject to a pre-existing divorce settlement agreement with the Reporting Person's former wife that covers the disposition of the options for her benefit.

(3) This price represents the weighted average of sales ranging from \$93.85 to \$94.00. Upon request by the Commission staff, the Issuer, or a security holder of the Issuer, the Reporting Person will provide full information regarding the number of shares sold at each separate price.
