**Item 1.01 Entry into a Material Definitive Agreement.**

Golden Telecom, Inc. (the "Company" or "GTI") filed a Current Report on Form 8-K on January 25, 2007 reporting that on January 25, 2007, the Company and two wholly-owned subsidiaries, GTS Finance, Inc. ("GFI") and EDN Sovintel LLC ("Sovintel") entered into a five-year Term Facility Agreement (the "Facility Agreement"), dated as of January 25, 2007, with banks, financial institutions and other institutional lenders as listed in Part II of Schedule 1 of the Facility Agreement ("Lenders"), Citibank, N.A. London Branch and ING Bank N.V. as mandated lead arrangers, and Citibank International plc as agent. The Facility Agreement establishes an unsecured credit facility under which the Company, GFI, and Sovintel may borrow up to an aggregate of \$275,000,000. Cross guarantees from the borrowers are required. Funds borrowed may be used for general corporate purposes, including acquisitions, the payment of dividends and capital expenditures.

On March 22, 2007, the Company, GFI, and Sovintel entered into an Amended and Restated Facility Agreement ("Amendment Agreement") with Lenders, Citibank, N.A. London Branch and ING Bank N.V and Citibank International plc. The Amendment Agreement provides for the \$275,000,000 to be divided into two separate facilities, one of \$50,000,000 and one of \$225,000,000. The first facility is available to be borrowed by GTI or GFI for a period of up to 90 days without the need for a cross guarantee from any of the other borrowers. The second facility is available to be borrowed by any of the borrowers under the original terms. A copy of the Facility Agreement dated January 25, 2007 as amended and restated on March 22, 2007 is attached hereto as Exhibit 10.2 and is incorporated herein by reference.
