(1) On January 29, 2016, Mr. Betz was granted an option to purchase 64,815 shares of common stock of Applied Minerals, Inc. The term is 10 years. 50% of the option vests on the first anniversary date of the grant and the remaining 50% vests on the second anniversary date of the grant.
