- (1) On January 19, 2016, Mr. Zamani was granted an option to purchase 81,522 shares of common stock of Applied Minerals, Inc. This grant is a component of the compensation Mr. Zamani will receive for serving as a Director of the Company for the 2016 calendar year. The exercise price of the option is \$0.30 per share. The term is 5 years. 50% of the option vests on the first anniversary date of the grant and the remaining 50% vests on the second anniversary date of the grant.
