(2) The reporting person received a total of 5,333 shares of Common Stock of the Issuer pursuant to the vesting provisions in the award of restricted stock units. A total of 1,709 shares were surrendered to satisfy tax obligations of the reporting person, resulting in the issuance of a total of 3,624 net shares of Common Stock.

(3) These restricted stock units have been adjusted (a) to preserve the intrinsic value of awards existing prior to the spin-off of a portion of the Issuer's ownership interest in The WhiteWave Foods Company on May 23, 2013 and (b) to reflect the reverse stock split on August 26, 2013.
