The number and the exercise price of all outstanding stock options granted under Forest's equity incentive plans were adjusted to reflect the spin-off.
- (3) This option becomes exercisable in four equal installments on each of the first four anniversaries of the date of grant.
- (4) The reporting person transferred an employee stock option to purchase shares 5,573 shares of Forest common stock to his former spouse pursuant to a qualified domestic relations order. The reporting person no longer reports as beneficially owned any securities owned by his former spouse.
