NORTH LIBERTY, IOWA - June 9, 2008 - Heartland Express, Inc. (Nasdaq: HTLD) The Board of Directors of Heartland Express, Inc. announced today the declaration of a regular quarterly cash dividend. The \$0.02 per share dividend will be paid on July 2, 2008 to shareholders of record at the close of business on June 20, 2008. A total of approximately \$1.9 million will be paid on the Company's 96.2 million outstanding shares of common stock.
