- (1) During the fiscal year under the Cedar Fair, L.P. Distribution Reinvestment and Employee Unit Purchase Plan, 150 units were acquired at prices ranging from \$27.58 to \$31.05. These transactions are exempt under rule 16a-11.
- (2) During the fiscal year under a broker administered distribution reinvestment plan, 18 units were acquired at prices ranging from \$30.07 to \$31.05. These transactions are exempt under rule 16a-11.
- (3) During the fiscal year under the Cedar Fair, L.P. Distribution Reinvestment and Employee Unit Purchase Plan, 27 units were acquired at prices ranging from \$27.58 to \$31.05. These transactions are exempt under rule 16a-11.
