Systemax Inc. (the Company) could not complete its filing on Form 10-K for the year ended December 31, 2005 (the 10-K) due to delays in the completion of its consolidated financial statements and related portions of the Form 10-K, which delays could not be eliminated by the Company without unreasonable effort and expense. The Company currently anticipates filing such form, as well as the Forms 10-Q for the first three quarters of 2005, by early June 2006.

This inability has been caused by delays related to the Company's need to restate its consolidated financial statements for the year ended December 31, 2004, which restated results were filed on November 22, 2005, to which the Company devoted considerable time and effort and delayed completion of the quarterly financial statements for the first three quarters of 2005 and thus commencement of work preparing the December 31, 2005 consolidated financial statements. In addition, the Company's former independent registered public accounting firm declined to stand for reappointment, as was previously reported, and the Company was unable to appoint a new independent registered public accounting firm until December 2005. The filing of the Form 10-K and the Forms 10-Q for 2005 is pending completion of the preparation and audit of the consolidated financial statements as of and for the year ended December 31, 2005.
