The shareholders of GLG Partners Limited are Noam Gottesman, Pierre Lagrange, Philippe Jabre and Lehman (Cayman) Limited, a subsidiary of Lehman Brothers Holdings, Inc., a publicly-held entity. The managing directors of GLG Partners Limited are Noam Gottesman, Pierre Lagrange and Emmanuel Roman, and as a result, each has voting and dispositive power over the securities held by the Funds. GLG Partners LP, GLG Partners Limited, Noam Gottesman, Pierre Lagrange and Emmanuel Roman disclaim beneficial ownership of the securities held by the Funds except for their pecuniary interest therein.

(b) Percent of class:

The Company's proxy statement on Form DEF 14A that was filed on December 28, 2005, indicates there were 21,550,612 shares of Common Stock outstanding as of December 15, 2005. Therefore, based on the Company's outstanding shares of Common Stock, (i) GLG North American Opportunity Fund may be deemed to beneficially own 5.78% of the outstanding shares of Common Stock of the Company, and (ii) GLG Partners LP, GLG Partners Limited, Noam Gottesman, Pierre Lagrange and Emmanuel Roman may be deemed to beneficially own 9.17% of the outstanding shares of Common Stock of the Company. The foregoing should not be construed in and of itself as an admission by any Reporting Person as to beneficial ownership of shares of Common Stock owned by another Reporting Person.
