#### PART III NARRATIVE

State below in reasonable detail the reasons why Forms 10-K, 20-F, 11-K, 10-Q, N-SAR, or the transition report portion thereof, could not be filed within the prescribed time period.

As disclosed in previous filings with the Securities and Exchange Commission, Clean Harbors, Inc. (the Company) purchased on September 10, 2002 (but effective as of September 7, 2002), the assets of the Chemical Services Division of Safety-Kleen Corp. (the CSD). When operations derived from the acquisition of the CSD assets are combined with those of the Company prior to the acquisition, the Company is expected to have annualized revenue of approximately three times that of the Company prior to the acquisition.

As anticipated prior to the acquisition, the Company has experienced certain delays in integrating the financial information of the former CSD into financial information of the Company in order to complete the combined balance sheet as of September 30, 2002, and the statements of operations and cash flows for the period ended September 30, 2002, which include approximately three weeks of combined operations. These delays have made it impracticable for the Company to file by November 14, 2002 its quarterly report on Form 10-Q for the third quarter of 2002. The Company anticipates filing such report on November 19, 2002.
