- (1) On February 23, 2007, the Partnership converted 525,200 shares of Class B Common Stock into shares of Class A Common Stock on a one-for-one basis for no cost; accordingly, there was no applicable purchase or sale (284,220 shares represents Mr. Tyson's pro-rata interest).
 - (2) On February 26, 2007, the Partnership converted 604,286 shares of Class B Common Stock into shares of Class A Common Stock on a one-for-one basis for no cost; accordingly, there was no applicable purchase or sale (327,019 shares represents Mr. Tyson's pro-rata interest).
 - (3) On February 27, 2007, the Partnership converted 11,000 shares of Class B Common Stock into shares of Class A Common Stock on a one-for-one basis for no cost; accordingly, there was no applicable purchase or sale (5,953 shares represents Mr. Tyson's pro-rata interest).
