This statement is filed pursuant to Rule 13d-2(b) promulgated under the Securities Exchange Act of 1934, as amended, with respect to the shares of common stock (the "Common Stock") of Access Integrated Technologies, Inc. (the "Issuer") beneficially owned by the Reporting Persons identified below as of December 31, 2006, and amends and supplements the Schedule 13G originally filed February 22, 2005, as amended (collectively, the "Schedule 13G"). Except as set forth herein, the Schedule 13G is unmodified.

The names of the persons filing this statement on Schedule 13G are: Basso Private Opportunities Holding Fund Ltd. ("Private Opportunities Holding Fund"), Basso Fund Ltd. ("Basso Fund"), Basso Multi-Strategy Holding Fund Ltd. ("Multi-Strategy Holding Fund"), Basso Capital Management, L.P. ("BCM"), Basso GP, LLC ("Basso GP"), Howard Fischer, Philip Platek, John Lepore and Dwight Nelson. BCM is the investment manager of Private Opportunities Holding Fund, Basso Fund and Multi-Strategy Holding Fund. Basso GP is the general partner of BCM. The controlling persons of Basso GP are Howard Fischer, Philip Platek, John Lepore and Dwight Nelson (each a "Controlling Person" and collectively, the "Controlling Persons").

#### ITEM 4. OWNERSHIP.

Provide the following information regarding the aggregate number and percentage of the class of securities of the issuer identified in Item 1.

### (a) Amount beneficially owned:

Private Opportunities Holding Fund beneficially owns 159,174 shares of Common Stock through its ownership of (i) 68,709 shares of Common Stock and (ii) warrants of the Issuer ("Warrants") exercisable for 90,465 shares of Common Stock.

Basso Fund beneficially owns 70,466 shares of Common Stock through its ownership of (i) 40,860 shares of Common Stock and (ii) Warrants exercisable for 29,606 shares of Common Stock.

Multi-Strategy Holding Fund beneficially owns 494,628 shares of Common Stock through its ownership of (i) 230,406 shares of Common Stock and (ii) Warrants exercisable for 264,222 shares of Common Stock.

BCM, as the investment manager of Private Opportunities Holding Fund, Basso Fund and Multi-Strategy Holding Fund, is deemed to beneficially own the 724,268 shares of Common Stock beneficially owned by them.

Basso GP, as the general partner of BCM, is deemed to beneficially own the 724,268 shares beneficially owned by BCM.

Each Controlling Person, in his capacity as a controlling person of Basso GP, is deemed to beneficially own the 724,268 shares of Common Stock beneficially owned by Basso GP.

Collectively, the Reporting Persons beneficially own 724,268 shares of Common Stock.

#### (b) Percent of Class:

Private Opportunities Holding Fund's beneficial ownership of 159,174 shares of Common Stock represents 0.7% of all the outstanding shares of Common Stock.

Basso Fund's beneficial ownership of 70,466 shares of Common Stock represents 0.3% of all the outstanding shares of Common Stock.

Multi-Strategy Holding Fund's beneficial ownership of 494,628 shares of Common Stock represents 2.1% of all the outstanding shares of Common Stock.

BCM's beneficial ownership of 724,268 shares of Common Stock represents 3.0% of all the outstanding shares of Common Stock.

Basso GP's and each Controlling Person's beneficial ownership of 724,268 shares of Common Stock represents 3.0% of all the outstanding shares of Common Stock.

Collectively, the Reporting Persons beneficially own 724,268 shares of Common Stock representing 3.0% of all the outstanding shares of Common Stock.
