- (1) Each RSU represents the right to receive one share of Common Stock, subject to adjustment as provided in the Grant Agreement.
  - (2) Pursuant to a one time offer by Enterprise Financial Services Corp, the reporting person has elected to exchange RSUs for Stock Settled Stock Appreciation Rights ("SSARs") at a ratio of 2.5 SSARs for each RSU surrendered.
  - (3) Each SSAR consists of the right to receive an amount, in common stock, equal to the excess of the fair market value of a share of common stock on the date of exercise over the exercise price of the SSAR. The SSARs vest at a rate of 20% annually over five years, subject to continued employment of the reporting person. Vesting occurs on December 15 of each year, commencing December 15,

The RSUs vest at a rate of 20% annually over five years, subject to continued employment of the reporting person.
