- The shares represent restricted stock units that were received as an award, for no consideration. The restricted stock unit shall vest as to
- (1) 25% of the shares on September 17, 2014 and 12.5% of the shares every six months thereafter, such that the shares are fully vested on approximately the four (4) year anniversary of the date of grant.
 - (2) Includes 1,190 shares purchased pursuant to the Issuer's Employee Stock Purchase Plan on August 30, 2013 and 3,750 shares issued upon the vesting of restricted stock units previously reported on a Form 4.
 - (3) Represents shares of the Issuer's common stock withheld by the Issuer to satisfy taxes due by the Reporting Person in connection with the vesting of restricted stock units previously reported on a Form 4.
 - (4) The option shall vest as to 25% of the shares on September 18, 2014 and 6.25% of the shares at the end of each quarterly period thereafter, such that the option is fully vested on the four (4) year anniversary of the date of grant.
