### Convertible Senior Subordinated Notes due 2018

This Prospectus Supplement No. 3 supplements and amends our prospectus dated August 11, 2003, as amended and supplemented by prospectus supplement no. 1 dated August 29, 2003 and prospectus supplement no. 2 dated September 16, 2003, relating to the resale from time to time by the selling securityholders of our Convertible Senior Subordinated Notes due 2018 and shares of our class A common stock issuable upon the conversion of the notes. You should read this prospectus supplement in conjunction with the prospectus, and this prospectus supplement is qualified by reference to the prospectus, except to the extent that the information in this prospectus supplement supersedes the information contained in the prospectus. The terms of the notes are set forth in the prospectus.

Lehman Brothers Inc. was an initial purchaser of a portion of the \$310.0 million of 8<sup>3</sup>/<sub>4</sub>% senior subordinated notes due 2011 offered in December 2001 and a portion of the \$125.0 million of 8% senior subordinated notes due 2012 offered in November 2002. Lehman Commercial Paper Inc. is a lender under our bank credit agreement.
