The Accounts are the owners of record of an aggregate of 285,329 Shares. None of the Funds or the Accounts individually own (beneficially or of record) more than 5% of a class of the Issuer's equity securities that are registered under Section 12 of the Securities Exchange Act of 1934, as amended. Under the terms of the relevant investment management agreements, Passport Capital has the right to dispose of and vote the Shares owned of record by the Funds and has the right to dispose of the Shares owned of record by the Accounts. The Accounts maintain sole power to vote and direct the vote of their Shares of record. Burbank is the sole managing member of Passport Capital. As a result, each of Passport Capital and Burbank may be considered to share (i) the power to vote or direct the vote of and (ii) the power to dispose or direct the disposition of, the Shares owned of record by the Funds, and may be considered to share the power to dispose or direct the disposition of the Shares owned of record by the Accounts. This statement on Schedule 13G shall not be construed as an admission that any of the Funds and the Accounts is the beneficial owner of the Shares covered by this statement.
