**ITEM 7.01 REGULATION FD DISCLOSURE.**

As a result of the recent volatility in the financial markets subsequent to the October 1<sup>st</sup> closing of Macerich's executive trading window, and the inability to quickly liquefy other assets, on October 9 and 10, 2008, a total of 345,173 Macerich shares were involuntarily sold by Mr. Arthur Coppola's broker to satisfy Mr. Coppola's collateral requirement under his line of credit with his brokerage firm. Mr. Coppola now owns approximately 445,119 shares of Macerich common stock (excluding any unvested restricted stock) in addition to 1,471,477 operating partnership units in The Macerich Partnership, L.P. The operating partnership units are owned free and clear, and are not encumbered by any loans. Mr. Coppola's remaining 445,119 shares of Macerich common stock secure his current line of credit balance of approximately \$13 million and may also be subject to future involuntary sales.
