**Item 2.02. Results of Operations and Financial Condition.**

On February 20, 2013, Fluor Corporation (the **Company** ) announced its financial results for the quarter and year ended December 31, 2012. A copy of the press release (the **Earnings Release** ) making this announcement is attached hereto as Exhibit 99.1 and incorporated herein by reference.

The Earnings Release contains a discussion of segment profit that would be deemed a non-GAAP financial measure under SEC rules. Segment profit is calculated as revenue less cost of revenue and earnings attributable to noncontrolling interests excluding: corporate general and administrative expense; interest expense; interest income; domestic and foreign income taxes; and other non-operating income and expense items. Fluor believes that this non-GAAP financial measure provides information that is useful to its investors regarding its financial performance and results of operations. In addition, the Earnings Release contains a discussion of net earnings attributable to Fluor, excluding the impact of a charge relating to the previously announced adverse ruling on the Greater Gabbard wind farm project ( Greater Gabbard ). Given the size of the charge relating to Greater Gabbard, the Company has shown net earnings excluding the charge in order to help better highlight underlying results. The Earnings Release includes reconciliations of such non-GAAP financial measures to the most directly comparable financial measures calculated and presented in accordance with GAAP.

Fluor Corporation includes backlog and new awards data in the Earnings Release. Backlog is a measure of the total dollar value of work to be performed on contracts awarded and in progress. Although backlog reflects business that is considered to be firm, cancellations or scope adjustments may occur. Backlog is adjusted to reflect any known project cancellations, revisions to project scope and cost, and deferrals, as appropriate. New awards is a measure of the total dollar value of work to be performed on contracts awarded in the period. Backlog and new awards measures are regularly reported in the construction industry.
