Item 2.02 Results of Operation and Financial Condition.

On October 6, 2016, Helen of Troy Limited (the Company) issued a press release announcing the results for the second fiscal quarter and six months ended August 31, 2016. Additionally, on October 6, 2016, the Company held a conference call discussing its results for the same period mentioned above. With this Form 8-K, we are furnishing copies of the press release (attached hereto as Exhibit 99.1) and the text of the conference call (attached hereto as Exhibit 99.2). The information contained on this website is not included as a part of, or incorporated by reference into, this report.
