- (1) Represents Special Incentive Stock Ownership Premiums (SISOPs) (phantom stock) awarded pursuant to the PG&E Corporation Executive Stock Ownership Program. SISOPs vest three years after the date of grant subject to accelerated vesting upon certain events. Unvested SISOPs are subject to forfeiture if certain stock ownership targets are not met. Vested SISOPs are automatically payable in an equal number of shares following termination of employment.
- (2) Includes 67.88 SISOPs awarded pursuant to the PG&E Corporation executive Stock Ownership Program, and reflects the acquisition of 0.19 SISOPs on 4/15/09, 0.20 SISOPs on 7/15/09, and 0.18 SISOPs on 10/15/09 upon conversion of dividend equivalents received on those dates.

- (3) Represents the approximate number of shares of PG&E Corporation common stock held for the reporting person in the PG&E Corporation Stock Fund of the PG&E Corporation Retirement Savings Plan (RSP). That fund holds units consisting of PG&E Corporation common stock and a small short-term investments component. The number of shares is computed by dividing the value of the units by the daily closing price. Dividends are automatically invested in additional units at the election of the participant. These holdings have been trued up to conform to the RSP balance as of 01/04/2010, and reflect the acquisition of approximately 1.72 shares on 4/15/09, 2.91 shares on 7/15/09, and 3.28 shares on 10/15/09 due to dividend reinvestment.
