- (1) This transaction was executed in multiple trades at prices ranging from \$153.79 to \$154.48. The price reported above reflects the weighted average sale price.   - (10) If the Company achieves certain goals over the 2016-2018 period, the performance units will vest and stock will be awarded. The target number of units that may be earned is reported above; the maximum amount is 200% of the number reported, subject to plan limits.
