- Unless earlier forfeited under the terms of the PSU, each PSU vests and converts into no more than 200% of one share of Intel common

- Due to a limitation in the filing software, the total number of shares of Common Stock received was 3,265 as reported above in Table I.
- (4) The conversion rate of the Performance-based Restricted Stock was 75.746%. Upon conversion of the RSUs, the Reporting Person received 3,029 shares of Common Stock. Upon conversion of \$11,002.84 in dividend equivalents, the Reporting Person received an additional 236 shares of Common Stock.
