### **UFC Middleweight Champion Rich Franklin Stars Opposite Bruce Greenwood and Tiffani Thiessen in Latest Addition To Peace Arch's Expanding Sales Pipeline**

Toronto November 27, 2007 Peace Arch Entertainment Group Inc. ([AMEX:PAE - News](#)) ([TSX:PAE.TO - News](#)), an integrated global entertainment company creating and acquiring critically acclaimed film and television content for worldwide distribution, today announced the start of principal photography of the action film *Weapon* starring UFC Middleweight Champion Rich Franklin opposite Bruce Greenwood ( *I Robot*, *Swept Away*, *Déjà Vu* ) and Tiffani Thiessen ( *She Fought Alone*, *Son in Law*, *TV's Beverly Hills 90210* ). The film is being produced by Joshua Gray and directed by John Stead, and is based on a screenplay by John Flock and Christopher Warre Smets. Executive producers are Jacqueline Kelly, Barbara Sacks, Kate Harrison and Lewin Webb. *Weapon* is currently filming in Hamilton, Ontario.

Our representation of *Weapon* is consistent with Peace Arch's strategy of building one of the largest independent film and television libraries in the world through high-volume production and third-party acquisitions, said co-writer and Peace Arch Entertainment President and Chief Operating Officer John Flock.
