**CONTROVERSIAL FILM DELIVERS NATIONS HIGHEST PER SCREEN AVERAGE OF \$13,900 ON WEEKEND OPENING**

**Toronto April 4, 2008** Peace Arch® Entertainment Group Inc. (AMEX:PAE - News) (TSX:PAE.TO - News), an integrated global entertainment company, today announced that its acclaimed and controversial feature film about the assassin of Beatle John Lennon, *Chapter 27*, delivered this past weekend's highest per screen average in the nation in its debut at New York City's Angelika theater with a three-day average of \$13,900. *Chapter 27* expands to 5 screens in New York and Los Angeles this weekend and will roll out to more than 25 additional cities, including San Francisco, Chicago, Boston and Seattle, over the next several weeks.

The psychological drama *Chapter 27*, a controversial exploration of Mark David Chapman's gradual breakdown during the days leading up to his murder of Lennon, features a riveting performance by Jared Leto (*Requiem For A Dream*, *Panic Room*, *Fight Club*), along with Judah Friedlander (*Zoolander*, *Meet The Parents*) and Lindsay Lohan (*Mean Girls*, *Freaky Friday*, *Herbie Fully Loaded*). ## GENERAL INSTRUCTIONS

A.

### Rule as to Use of Form 6-K,

**Information and Document required to be Furnished,**

Subject to General Instruction D herein, an issuer furnishing a report on this form shall furnish whatever information, not required to be furnished on Form 40-F or previously furnished, such issuer (I) makes or is required to make public pursuant to the law of the jurisdiction of its domicile or in which it is incorporated or organized, or (ii) files or is required to file with a stock exchange on which its securities are traded and which was made public by that exchange, or (iii) distributes or is required to distribute to its security holders.

At least one of the copies deposited with the Commission and one filed with each such exchange shall be manually signed. Unsigned copies shall be conformed.
