- (1) Grants of restricted stock and options made to the independent members of the Company's Board of Directors in September 2008 were rescinded by the Compensation Committee and the Board of Directors due to management's failure to provide documentation timely, which resulted in the inability of the recipients of restricted stock grants to timely file an 83(b) election with the Internal Revenue Service within the prescribed 30 day period. To ensure equal treatment among independent directors, this grant of options was also rescinded.
 - (2) The stock option granted under the Company's Long Term Incentive Plan vests in its entirety upon the third anniversary of the stock option grant (12/8/2011).
