The RSUs vest in full on the one-year anniversary of the date of grant. The reporting person has elected to defer the RSUs under the Company's 2008 Deferred Compensation Plan. Following the one-year anniversary of the date of grant, the RSUs will thereafter become payable in shares of Common Stock upon the termination of the reporting person's service as a director of the Company, in accordance with the terms of the 2008 Deferred Compensation Plan.
- (3) Each share of Phantom Stock represents the right to receive one share of Series A Common Stock.  
The Phantom Stock represents Restricted Stock Units deferred under the Company's 2008 Deferred Compensation Plan. The shares of Phantom Stock are payable in cash or shares of Series A Common Stock, as provided in the Company's 2008 Deferred Compensation Plan, following the termination of the reporting person's service as director of the Company.
