PART III – NARRATIVE

Apogee lacks sufficient funds to pay for a review of our financial statements for the quarter ended March 31, 2010.

We are working to obtain funding in order to allow us to pay for (i) an independent audit and, therefore, allow us to file our Annual Report on Form 10-K for the year ended December 31, 2009, and (ii) a review and, therefore, allow us to file our Quarterly Report on Form 10-Q for the quarter ended March 31, 2010. We plan to make these filings as soon as we have attained such funding and an audit opinion and review from our independent registered public accounting firm. We cannot currently anticipate when this will be.
